Communiqué

Austroads Board Meeting No. 52 9 May 2024 | Auckland, New Zealand



The Austroads Board met on 9 May 2024 in Auckland, New Zealand. The meeting was chaired by Louise McCormick, Infrastructure Commissioner, Infrastructure NT, Department of Infrastructure, Planning & Logistics Northern Territory.

The Chair acknowledged the Treaty of Waitangi and Māori as the original people of New Zealand (Aotearoa). She also acknowledged the Australian indigenous peoples as the first peoples of Australia.

Appointment of Deputy Chair

The Board approved the appointment of Brett Gliddon as deputy chair as the former Deputy Chair Gary Swain left the Department of State Growth, so was no longer eligible to be an Austroads Board member. Gary was promoted to the role of Secretary, Department of Treasury and Finance Tasmania.

Austroads risk management

The Risk Committee Chair provided an update on the committee meeting, noting IT risks, workforce capacity challenges, and the need for national harmonisation to drive efficiency, while also highlighting the importance of board continuity.

Austroads Medal

The Board noted Neil Scale's receipt of the Austroads Medal awarded to a person who has made an exceptionally meritorious contribution to Austroads. Neil's medal is only the twelfth awarded..

Road Safety Week

The meeting was held during the Road Safety Week in Australia. It was highlighted that Austroads is committed to the goal of zero road fatalities.

Climate change and resilience

The Board discussed supply chain risks arising from weather events, government priorities affecting skilled labour, and the BITRE report, which highlights rail's climate vulnerability. The need for upcoming initiatives to address resilience, decarbonisation, and workforce issues was emphasised. The Board agreed that these topics should be key focuses of the Resilience Transport 2025 seminar and decided to table agenda topics for the seminar at the August meeting.

Priority projects

Harmonisation of Temporary Traffic Management Practice

The Board approved publishing the report on the first 18 months' operation of the Austroads Innovative Temporary Traffic Management Device and Solution Assessment (AITDSA) Scheme. The Board also agreed to delegate to the Austroads Chair the approval of the IT Registry development work.

National Heavy Vehicle Driver Competency Framework - Implementation

The Board approved the establishment of a Steering Committee to develop a draft Inception Report by August 2024 and to commence detailed policy work on licensing and training.

Austroads as a Digital Driver Licence and Credential Verifier

The Board approved the project and associated budget.

National Heavy Vehicle Access System

The Board approved pausing work once Stage 1 deliverables are completed, with the project not recommencing until agreed upon by the Board.

Austroads Technical Specifications

The Board was updated on the progress of adopting the Austroads Technical Specifications (ATS), with plans to continue under current arrangements for the next few years while developing a sustainable business case. The Austroads Technical Advisory Group (ATAG) is effective, and despite challenges, a significant increase in ATS adoption is expected over the next 12 months.

Other priority projects

The Board approved the implementation of the National Prequalification Scheme and the rescheduling of the following projects: HVNL Technology and Data Framework – Design and Transition Planning (TCA6454) and Vehicle data exchange trial – phase 2 (TCA6457).
